



January Mayor's Note

Dear Residents of Cumming,

I would like to take this opportunity to thank you. Thank you for electing me as your new mayor. My wife, Renee, and I moved to Cumming in November 2016 after I retired. I quickly became active in the city by applying, and then being appointed to, the Planning and Zoning Commission in January of 2017. I served two years before joining the Cumming City Council in 2019.

As I move into my new position as mayor, it leaves a space to fill on the city council. This seat will have a term ending on December 31, 2023. The City Council will discuss how to fill this position at the next council meeting on Monday, January 10, 2022. I would like to express my gratitude to Mayor Tom Becker for his many years of service to the City of Cumming. Under his leadership we were able to begin the Great Western Crossing development, build a new city park, host a successful Home Show Expo, birthed a relationship with Ragbrai for an annual fall ride that will begin and end in Cumming each year and began a study in Old Town for a project that could remove septic tanks and put in new streets, curb and gutter.

Our city has had many exciting changes in the last few years and we have several more planned. We recently have formed a Steering Committee to work on the Comprehensive Plan. The committee is made up of at-large city residents, local business owners and city board and committee members. This group will be working with McClure Engineering and utilizing their Comprehensive Planning Services. We will be asking for more involvement from residents on this project at various events/mailings in the coming months.

An update on development: The Great Western Crossing development is steadily growing and our community has gained new residents. Developers are working with the city to move forward with The Villas, Townhomes and commercial projects.

The largest project that is in development is the Hy-Vee Distribution Campus. The City applied, and was awarded, a 1.3 million grant from the Revitalize Iowa's Sound Economy (RISE) program to make the necessary improvements on G-14 and 50th to move forward with this project. The construction, engineering, management fees and anything outside the scope of this grant, will be paid for by Hy-Vee, not the city. Construction should begin on this project in May, and are expected to be completed by mid-November of this year.

The Fast and Fresh convenience store, gas station and Smokey Row coffee shop are also moving forward. The expectant completion date for this project is towards the end of 2022, subject to material being delivered. Supplies, such as fuel tanks, have been ordered however they are on backorder with long wait times expected. The development agreement for this project will be on the January 24th council meeting along with a public hearing.

The city website is a very useful tool and the calendar will keep you up-to-date on when meetings and events are happening. Contact information is on the website too, along with agendas and minutes of meetings. Our Facebook page is also a good resource and another location to find the weekly and monthly newsletters.

Please feel free to reach out to me at any time. I look forward to serving, and working with you, to keep Cumming home.

69.10 SNOW REMOVAL.

No person shall park, abandon or leave unattended any vehicle on any public street, alley, or City-owned off-street parking area during snow removal operations unless the snow has been removed or plowed from said street, alley or parking area and the snow has ceased to fall.

136.03 REMOVAL OF SNOW AND ICE.

The abutting property owner shall remove snow, ice, and accumulations promptly from sidewalks, or if ice cannot be removed, to treat the ice with sand, salt, or other non-slippery substance on a continuous basis while the ice is present. The cleaned or treated area of the sidewalk must be a minimum of 36 inches wide. If a property owner does not remove snow, ice, or accumulations within 48 hours after cessation of snow or ice fall, or continue to treat the surface while the ice is present, the City may do so and assess the costs against the property owner for collection in the same manner as a property tax. The abutting property owner may be liable for damages caused by failure to remove snow, ice, and accumulations promptly from the sidewalk.
